providing significant contributions to the economic development of the far north region. His expertise has been instrumental in shaping regional policies and strategies, and he has provided staunch support to CQUniversity since the Cairns campus was established in 2012. His extensive experience, coupled with his ability to provide insightful analysis and recommendations, has made him a trusted advisor in numerous businesses, educational institutions, media companies, development organisations, and government advisory committees, and he has been involved in many aspects of the growth and success of CQUniversity's Cairns campus.

Graduating with a Bachelor of Economics from the University of Queensland in 1962, Bill pursued further studies in Economics and Political Science at the Australian National University in Canberra, before returning to Cairns in 1968, managing development and tourism promotional organisations. Bill played a significant role over the next 13 years promoting and developing domestic and international tourism in the far north region, including managing the Ingham District Research and Promotion Bureau, the Far North Queensland Development Bureau and Tourism Tropical North Queensland. He was an active advocate for the upgrading of the Cairns airport, promoting trade with Papua New Guinea, and achieving fishing industry infrastructure upgrading. Bill was also heavily involved in promoting agricultural diversification, roads, mining development, and reforestation.

In 1981, Bill established his own economic and market research business coordinating development promotion in the Cairns/Far North Queensland region. He conducted market research, feasibility studies and economic analysis to secure funding and win large scale projects that has further progressed the Northern Australian region. Bill's stewardship and strategic focus on tourism, primary industries, fishing, mining, retailing, university development, transport infrastructure, and road development throughout his service on various committees, including the Cairns Chamber of Commerce and Federation of Chambers of Commerce of Far North Queensland, have been instrumental in shaping regional policies and strategies.

Bill is held in high regard by the Cairns community for his significant contributions to the economic development of the region and his service to the community for over fifty years. CQUniversity is proud to acknowledge Bill's long-term role as a trusted advisor to the region's business and government leaders, in addition to his support to CQUniversity and his dedicated involvement to the Cairns campus.
